

POWER OF ATTORNEY

I, the undersigned:

hereby grant power of attorney to:

In the event of my failure to mention all the facts and evidence I have at my disposal within the time frames referred to in the preceding paragraph, the Law firm shall not be required to accept the power of attorney, or may cancel the power of attorney, and shall not be responsible for any damages incurred as a result of my failure to take action.

I hereby undertake to pay all costs of legal services at first call and in a timely manner, as per the Slovenian Bar Association's Pricelist, or, if a separate written agreement regarding legal fees exists, according to the said agreement. I shall also cover any costs and expenses incurred in the course of carrying out individual tasks.

I hereby undertake to notify the Law firm of any changes of my contact information (address, telephone number) immediately and no later than within 48 hours following any such change, and provide new contact information where I can be contacted, failing which the Law Firm shall be relieved of any liability for damages incurred as a result of my failure to notify the Law firm of the change in information. I agree that the Law firm shall send me all the writings by non-certified mail and I understand that the Law firm has informed me that the outcome of legal proceedings are unpredictable, and accepts only the obligation to act with diligence and professionalism due, and can offer no guarantee of success.

The issuer of this power of attorney and the Law firm agree that competent Courts of local to the Law firm's registered office shall have jurisdiction over any disputes arising in connection with this power of attorney.
